CLEARING PROCESS IN KOLKATA PORT.

Prior to the arrival of the goods, the following documents in original shall be handed over by the importer to **Tamu Worldwide Shipping Pvt. Ltd.** before the arrival of goods to avoid demurrage.

Documents required :

- 1 - Original Importers Authorization
- 2 - Original commercial Invoice
- 3 - Original Packing List
- 4 - Original Import License issued by MOEA, which CIF value must be tally with th Invoice CIF value.
- 5 - Bill of Lading, endorsee by consignee.
- 6 - Certificate of Origin.
- 7 - Marine Insurance policy up to Bhutan.

AIR CARGO CLEARING IN PARO INTERNATIONAL AIRPORT

Documents required:

- 1 - Import Declaration form.
- 2 - Import License (RRCO Copy)
- 3 - Commercial Invoice.
- 4 - Packing list.
- 5 - Certificate of Origin.
- 6 - Import Duty Exemption Certificate, where applicable.
- 7 - Bhutan Sale Tax Exemption Certificate, where applicable

CLEARANCE OF GOODS AT POINT OF ENTRY IN BHUTAN

If goods are not cleared within 7 days from the issue of arrival intimation notice served to the party-the importer will be levied storing from the dates of issue of arrival intimation notice.

Documents required:

- 1 - Import Declaration form.
- 2 - Import License (RRCO Copy)
- 3 - Commercial Invoice.
- 4 - Packing list.
- 5 - Certificate of Origin.
- 6 - Import Duty Exemption Certificate, where applicable.
- 7 - Bhutan Sale Tax Exemption Certificate, where applicable.

IMPORT PROCEDURES OF BHUTAN

Document Required

- 1 - Valid Retail / Wholesale Trade License.
- 2 - Commercial Invoice or Proforma Invoice.
